For violations occurring in school zones: \$132.00 (\$122.00 court costs and \$10.00 fee)

I understand that I must present to the court within 90 days of being granted Driver's Safety: (initial each)

- [redacted] A certified copy of my driver's record from the Department of Public Safety. You may request your driver's record on line at TexasOnline.com (record type 3A only) or by mailing the Application for Driver's Record (DR-1 form) to the DPS. (see printable forms-Request for Driver's Record(DR-1) on Lake Worth website)
[redacted] A uniform certificate of driving safety course completion from a Texas Education Agency approved. (Driving Safety Course Information online at www.tea.state.tx.us/drive/activetestds.html); and

- [redacted] If I complete a driving safety course within the required time, the charge against me will be dismissed and the court will report to theDepartment of Public Safety the completion date of the driving safety course for inclusion on my driving record.
[redacted] If I fail to present to the court proof of completion of the driving safety course and a copy of my driving record within the time required, the court will require my appearance at a show cause hearing date stated on the Driver's Safety Course Completion Information that will be mailed to me when my request has been granted.
