

CLEAN IN 3818

CODE COMPLIANCE INITIATIVE

Lake Worth's Code Compliance Department will continue the city's Code Compliance Initiative with "Clean in 2019". Lake Worth is committed to promoting and protecting the health, safety, and welfare of all its residents, business owners, and patrons while protecting and improving the overall beauty of the city.

It's the hope of city staff to inform and teach residents and business owners alike about rules and regulations pertaining to the city's most frequented code offenses through mailings each quarter, the city's website, city newsletters and social media. Each month a different offense will be focused on. The Code Officer will patrol the entire city noting violations and issuing warning postcards detailing the offense and how to remedy the situation, in the hopes of voluntary compliance. Enforcement, through court summons or city-initiated abatements will only be necessary for repeat offenders and those who ignore warnings.

The code compliance initiative program was established to compliment residents' efforts to maintain neighborhood desirability and encourage reinvestment. By working together, we can keep Lake Worth an attractive, healthy, and safe community!

Below are some of the most common violations the code enforcement staff addresses daily:

- High Grass & Weeds
- Property Maintenance/Lack of Building Address
- Dilapidate Fences
- Illegal Outside Storage
- Junk, Trash, and Debris on Premises
- Brush & Bulky Trash
- Garage Sale Permits
- Parking Regulations Junk/Abandoned Vehicles
- Pet Registrations
- Irrigation Restrictions
- Encroachments (Obstructions)
- Illegal Signage
- Vacant/Substandard Buildings
- RV's and Travel Trailers



JANUARY 2019 – CODE COMPLIANCE INITIATIVE ANNUAL PET REGISTRATION

City Code requires that any dog or cat residing within the city limits obtain annual city registration for each animal. See code section below for specifics.

1-year rabies vaccination registration is \$3.00 and 3-year rabies vaccination registration is \$6.00.



ARTICLE 2.300 ANNUAL REGISTRATION

(a) <u>Required</u>. The owner of a dog or cat that is four months of age or older must register each such dog or cat with the city. A registration may be obtained in person or by mail upon providing:

(1) A certificate of vaccination for the cat or dog showing that the cat or dog has received a rabies vaccination within the last 36 months and including the following information:

(A) The name, address, and telephone number of the owner of the vaccinated dog or cat;

- (B) The date of vaccination;
- (C) The year and number of the rabies tag;
- (D) The breed, age, color, and sex of the vaccinated dog or cat; and
- (E) Whether the dog or cat is neutered, spayed, or intact; and
- (2) The payment of the registration fee as set by the city council.

(b) <u>Metal tag</u>. The city will issue a metal tag for the dog or cat upon the registration. The owner of the dog or cat shall attach the current registration tag to a collar or harness that is worn at all times by the dog or cat. All registration tags shall be valid for a period of one (1) year from the date of issuance.

(c) <u>Duplicate tags</u>. The owner of a dog or cat may obtain a duplicate registration tag upon payment of a duplicate tag fee and presentation of the receipt showing payment of the current year's registration fee.

(d) <u>Renewal</u>. The owner of a dog or cat shall annually renew the registration with the city. The same proof of current rabies vaccination and payment of the registration fee that is required for the initial registration is required for a renewal.

(e) <u>New residents</u>. A person moving into the city from an area outside of the city has 30 days to comply with this article.

(f) <u>Guard or attack dogs</u>. The owner of a guard or attack dog shall:

(1) Indicate on the registration application that the dog is a guard or attack dog and the location and hours of presence of the dog;

(2) Register the guard or attack dog with the police department; and

(3) Conspicuously post warning signs stating "guard dog on premises" in letters not less than 2 inches high at the location or premises where the guard or attack dog is confined.

FEBRUARY 2019 – CODE COMPLIANCE INITIATIVE

PARKING REGULATIONS

City Ordinance prohibits parking in front/side yards. Vehicles must be on an approved paved surface or if driveway is not paved, all vehicles must be parked within the confines of the drive approach (curb cuts for a driveway).

ARTICLE 14.500 DISTRICT REGULATIONS*



Sec. 14.501 "SF-1" Single-Family District

(g) <u>Parking Regulations</u>. The following parking regulations shall apply:

(1) A minimum of two off-street parking spaces per dwelling unit located behind the front building line; provided, however, that at least one parking space shall be located within a private garage.

(2) Parking spaces and any adjoining private driveways shall be constructed of an improved monolithic surface of concrete or asphalt or other paved surface approved by the building official. The paved surface shall be two inches (2") or more in thickness and shall not exceed one-half inch (1/2") in height above the adjacent unpaved surface. On nonconforming lots without paved parking spaces and driveways, the parking spaces and driveways shall only be located perpendicular to the curb cut or drive approach or in the rear yard as authorized by Subsection (g)(4) and may not encroach into any portion of the remaining front yard. (See Diagram 1-A)

Editor's note-Diagram 1-A has not been printed and is attached to Ordinance 776 on file in the office of the city secretary.

(3) All vehicles shall be driven and parked so as to completely rest upon a paved surface. On nonconforming lots without paved parking spaces and driveways, all vehicles shall be driven and parked so as to completely rest upon the unpaved parking spaces or driveway as provided in this section, or in the side yard adjacent thereto. (See Diagram 1-B)

Editor's note-Diagram 1-B has not been printed and is attached to Ordinance 776 on file in the office of the city secretary.

(4) All vehicles parked or stored in the required rear yard of a structure must be placed behind a screening partition of fencing materials or dense vegetation so as to obscure the vehicle from view from a public street or public right-of-way. In addition, the parking or storage area and driveway (from the curb cut or drive approach to the parking or storage area) must be constructed of paved monolithic concrete or asphalt or other paved surface approved by the building official.

The City of Lake Worth held a Special Election on Tuesday, November 6, 2018. The purpose of this Election was to see if the voters wished to reauthorize the Crime Control and Prevention District ¼ Sales Tax for ten years. The results were in favor and the Crime Control Prevention District ¼ Sales Tax will continue through 2028.

The next General Election for the City of Lake Worth will be held on Saturday, May 4, 2019. The purpose of the election is to elect the following positions:

Mayor

City Council, Places 2 City Council, Place 4 City Council, Place 6

These are two-year terms from 2019-2021. Qualified and eligible persons interested in signing up may do so beginning Wednesday, January 16, 2019. Election packet information may be obtained through the City Secretary's office beginning on Friday, January 4, 2019. The deadline to file for application for a place on the ballot is by **5:00 pm** on Friday, February 15, 2019.

City Charter qualifications and eligibility requirements are:

The City Charter provides that the governing and lawmaking body of the City shall consist of the Mayor and seven (7) Council members who shall be elected for a term of two years. All places, including the Mayor, will be elected at large.

SECTION 3.02 QUALIFICATIONS:

Candidate Qualifications: Each person who becomes a candidate for Mayor or Council member shall meet the following qualifications:



KETO (LOW CARB) CHEESECAKE CUPCAKES

For the filing:

8oz. cream chesses (softened)

1 whole egg

1 c. sour cream

Juice and zest of 1 lemon

1 tsp. vanilla

1/2 c. sugar free sweetener (ex. Swerve or Splenda)

For the crust:

1 c. Almond flour

¼ c. walnuts

3 tbsp. melted butter

1/2 tsp. cinnamon

¼ c. Brown sugar substitute (ex. Swerve or Splenda brown sugar)

¼ tsp salt

Pulse all the crust ingredients in a food processor until you have a wet, crumbly mixture. Spoon crust mixture in to a lined cupcake tin (makes 12-15). Press down with back of the spoon to form the bottom of the cheesecake. <u>Bake the crust at 325 for 5-6 minutes</u>. Then spoon equal parts of the filing mixture in to your 12-15 cupcakes and <u>bake at 325 for 20 minutes</u>.

Safe Harbor Initiative

Anyone who has outstanding warrants with the Lake Worth Municipal Court is urged to appear at the court office to resolve their outstanding charges. Defendants that appear in the court office *will not be arrested* for outstanding warrants issued by the Lake Worth Municipal Court. You may be eligible for alternative ways to payment, such as community service or a reduction in the fine amount.

Your warrants will be recalled, and you will be scheduled to see the Judge to discuss your situation. Please contact the Lake Worth Municipal Court at 817-255-7910 to see if you have any outstanding charges that need to be resolved or if you have any questions.

The new rates are effective April 2019 water bill.

If you have a leak during this time frame and have it repaired, you will need to fill out and submit a request for reconsideration of winter sewer average. Your completed form should be accompanied by proof of the leak being fixed. An acceptable proof of repair includes but is not limited to: a plumber's invoice or store receipt of parts purchased.




