

2018 Code Compliance Initiative

The City of Lake Worth is committed to promoting and protecting the health, safety, and welfare of all of its residents, business owners, and patrons as well as protecting and improving the overall beauty of the city. With this in mind, the City is introducing a Code Compliance Initiative for 2018 in order to ensure that properties within the city limits are maintaining compliance with the City of Lake Worth's Code of Ordinances. It is part of the Lake Worth Code Compliance Department's mission to achieve voluntary compliance with our ordinances, and as such we are taking an education first approach with this initiative followed by enforcement when needed.

As the Code Compliance Initiative moves forward, the City will be sending out mailers/flyers and keeping the Code Compliance webpage up to date with more specifics on various violations, compliance education, and community resources to help gain voluntary compliance. If you or somebody you know is aware of a volunteer group or association in the Lake Worth community that may be able to assist those in need with obtaining compliance on their properties, please let our office know and we will make sure to add them as a community resource on our website.

SEPTEMBER 2018 EMPHASIZED VIOLATION PARKING REGULATIONS

ARTICLE 14.500 DISTRICT REGULA-TIONS*

Sec. 14.501 "SF-1" Single-Family District

- (g) <u>Parking Regulations</u>. The following parking regulations shall apply:
 - (1) A minimum of two off-street parking spaces per dwelling unit located behind the front building line; provided, however, that at least one parking space shall be located within a private garage.
 - Parking spaces and any adjoining private driveways shall be constructed of an improved monolithic surface of concrete or asphalt or other paved surface approved by the building official. The paved surface shall be two inches (2") or more in thickness and Sec. 8.501 shall not exceed one-half inch (1/2") in height above the adjacent unpaved surface. On nonconforming lots without paved parking spaces and driveways, the parking spaces and driveways shall only be located perpendicular to the curb cut or drive approach or in the rear yard as authorized by Subsection (g)(4) and may not encroach into any portion of the remaining front yard. (See Diagram 1-A)

Editor's note–Diagram 1–A has not been printed and is attached to Ordinance 776 on file in the office of the city secretary.

(3) All vehicles shall be driven and parked so as to completely rest upon a paved surface. On nonconforming lots without paved parking spaces and driveways, all vehicles shall be driven and parked so as to completely rest upon the unpaved parking spaces or driveway as provided in this section, or in the side yard adjacent thereto. (See Diagram 1–B)

Editor's note—Diagram 1—B has not been printed and is attached to Ordinance 776 on file in the office of the city secretary.

(4) All vehicles parked or stored in the required rear yard of a structure

must be placed behind a screening partition of fencing materials or dense vegetation so as to obscure the vehicle from view from a public street or public right-of-way. In addition, the parking or storage area and driveway (from the curb cut or drive approach to the parking or storage area) must be constructed of paved monolithic concrete or asphalt or other paved surface approved by the building official.

ABANDONED/JUNK VEHICLES

ARTICLE 8.500 ABANDONED AND JUNKED VEHICLES*

Sec. 8.501 Definitions

As used in this article, the following words and terms shall have the meanings provided in this section:

<u>Antique Vehicle</u>. A passenger car or truck that is **Public Nuisance** at least twenty-five (25) years old.

<u>Junked Vehicle</u>. A vehicle that is self-propelled and:

- (1) Does not have a valid registration lawfully attached to it;
- (2) Is wrecked, dismantled or partially dismantled, or discarded; or
- (3) Is inoperable and has remained inoperable for more than:
- (A) Seventy-two (72) consecutive hours if the vehicle is on public property; or
- (B) Thirty (30) consecutive days if the vehicle is on private property.
- (4) For the purpose of this article, "junked vehicle" includes a motor vehicle, aircraft, or watercraft. This article applies only to:

- (A) A motor vehicle that displays an expired registration or does not display a license plate;
- (B) An aircraft that does not have lawfully printed on the aircraft an unexpired federal aircraft identification number registered under Federal Aviation Administration aircraft registration regulations in 14 C.F.R part 47; or
- (C) A watercraft that:
- (i) Does not have lawfully on board an unexpired certificate of number; and
- (ii) Is not a watercraft described by section 31.055 Parks and Wildlife Code.

Motor Vehicle Collector. A person who:

- (1) Owns one or more antique or special interest vehicles; and
- (2) Acquires, collects, or disposes of an antique or special interest vehicle or part of an antique or special interest vehicle for personal use to restore and preserve an antique or special interest vehicle for historic interest.

<u>Special Interest Vehicle</u>. A motor vehicle of any age that has not been changed from original manufacturer's specifications and, because of its historic interest, is being preserved by a hobbyist.

Sec. 8.502 Junked Vehicles Declared Public Nuisance

A junked vehicle, including a part of a junked vehicle, that is visible at any time of the year from a public place or public right-of-way:

- (1) Is detrimental to the safety and welfare of the general public;
- (2) Tends to reduce the value of private property;
- (3) Invites vandalism;
- (4) Creates a fire hazard;
- (5) Constitutes an attractive nuisance creating a hazard to the health and safety of minors;
- (6) Produces urban blight adverse to the maintenance and continuing development of the city; and
- Is a public nuisance.

Sec. 8.503 **Notice**

- The procedures for the abatement and (a) removal of a public nuisance under this article must provide not less than ten (10) days' notice of the nature of the nuisance. The notice must be personally delivered, sent by certified mail with a five-day return requested, or delivered by the United States Postal Service with signature confirmation service to:
- (1) nuisance;
- Each lienholder of record of the nuisance; (c) (2) and
- The owner or occupant of the property (3)upon which the nuisance is located or the owner or occupant of the premises adjacent to the public right-of-way on which the nuisance is located.
- The notice must state that:
- The nuisance must be abated and removed not later than the tenth (10th) day after the date on which the notice was personally delivered or mailed:
- Any request for a hearing must be made before that 10-day period expires; and
- Failure to abate the nuisance or failure to attend the hearing after notice constitutes a waiv- (1) er by the owner and lienholders of all right, title cle's: and interest in the vehicle and their consent to dispose of the junked vehicle under the terms of (A) chapter 683 of the Texas Transportation Code.
- If the post office address of the last known registered owner of the nuisance is unknown, (C) notice may be placed on the nuisance, or, if the owner is located, personally delivered.
- (d) If any notice is returned undelivered by the United States Post Office, official action to abate the nuisance shall be continued to a date not earlier than the eleventh (11th) day after the date of the return of the notice.

Sec. 8.504 Hearing

If the junked vehicle is not removed and abated within the prescribed time period. the municipal court judge shall hold a public hearing on the abatement and removal of the

 - For a watercraft, the watercraft's:

Sec. 8.506 Junked Vehicles Not to be Reconstructed or Made Operable After Removal

After any junked vehicle has been removed under the authority of this article, it shall not For a motor vehicle, the motor vehi- be reconstructed or made operable again.

Sec. 8.507 Notice to Department of **Transportation**

No later than the fifth (5th) day after the date of removal of a junked vehicle pursuant to this article, notice must be given to the state department of transportation. Such notice must identify the vehicle or vehicle part.

Sec. 8.508 **Disposal of Junked Vehicles**

Any junked vehicles taken into custody by the city or any duly authorized person pursuant to a provision of this article shall be disposed of in accordance with applicable provisions of chapter 683 of the Texas Transportation Code.

Sec. 8.509 **Application of This Article**

The provisions of this article shall not apply to a vehicle or vehicle part that is:

- Completely enclosed within a building in a lawful manner where it is not visible from the street Sec. 8.512 Abandoned Vehicles or other public or private property; or
- Stored or parked in a lawful manner on private property in connection with the business of a licensed vehicle dealer or junkyard, or that is an antique or special interest vehicle stored by a motor vehicle collector on the collector's property, if the vehicle or part and the outdoor storage area, if any, are:
- Maintained in an orderly manner; (A)
- (B) Not a health hazard; and
- Screened from ordinary public view by appropriate means, including a fence, rapidly growing trees, or shrubbery.

Sec. 8.510 Offense


- A person commits an offense if the person maintains a public nuisance described by Section 8.502.
- An offense under this article is a misde-(b) meanor punishable by a fine in accordance with the general penalty provision set forth in Section 1.109 of this code. Each day an offense occurs shall be a separate offense.

Sec. 8.511 **Enforcement**

- Any peace officer, code enforcement officer or other regularly salaried, full-time city employee is authorized to enforce this article. Such employee may issue a warning or a citation before issuing a notice pursuant to Section 8.503.
- Upon conviction of a violation of this article. the municipal court judge shall order that the vehicle be abated and removed within a prescribed period of time. The judge's order shall provide that if the vehicle is not removed within the prescribed period of time, the city may remove the vehicle in accordance with state law.
- The enforcement remedies authorized under this article shall not be deemed exclusive and the

city reserves the right to seek any enforcement remedy available at law or in equity. The failure of the city to seek enforcement by any means shall not foreclose the enforcement of this article by any other means.

An abandoned vehicle left upon public property or public rights-of-way constitutes a nuisance and may be abated in accordance with state





SEPTEMBER PARKING REGULA-TIONS

Motor vehicles, trailers, boats, and/or RV's cannot be parked in the yard.

They must be parked on an approved monolithic surface in the driveway or on the street.



OCTOBER JUNK/ABANDONED **VEHICLES**

All vehicle(s) must be properly and currently registered and inspected.

Vehicles must not be wrecked, dismantled, or partially dismantled and cannot remain inoperable.




