### 1. Call to Order.

Mayor Walter Bowen called the Council Workshop/Special meeting to order at 6:30 p.m.

# 2. Invocation and Pledge of Allegiance.

#### 3. Roll Call.

4. Workshop by Council and Presentation by Townsite, LLC regarding the Land Use Plan, Economic Development Analysis, Project Phasing, Infrastructure Analysis, and Preferred Development Process for Hotel/Conference Center funding for the proposed Pent property development for a Hotel/Conference Center.

Phillip Poole, development consultant with Townsite, LLC, presented to Council a proposed development plan and concept design for a Hotel/Conference Center on 29.84 acres of property within the City. After the presentation, Mr. Poole answered questions from Council. Mr. McGuire noted that the property owner has withdrawn his offer to sell the property to the City and has indicated he will develop the property himself. Therefore, the City will need to recognize (at the next Council meeting) that the City will not be moving forward as developer. The property owner has requested a committee be formed (comprised of the City Manager, Assistant City Manager/Director of Finance, Mayor, and two Council Members) for him to work with during his process. The Mayor indicated he has spoken with Council Members Geoffrey White and Gary Stuard to serve on that committee. Therefore, the committee members will be Brett McGuire, City Manager; Debbie Whitley, Assistant City Manager/Director of Finance; Mayor Walter Bowen; and Council Members Geoffrey White and Gary Stuard.
