**WAIVER OF TRIAL AND MOTION FOR DEFERRED DISPOSITION**

I hereby make my motion for Deferred Disposition and wish to enter a plea of:

By signing below, **I affirm I meet and understand the following conditions:**

1. I hereby waive my right to a jury trial or a hearing by the court and I decline to review the evidence, if any, in this case.
2. I must provide a legible copy of my valid driver's license or picture identification with this request;
3. I currently do not have a Commercial Driver's License and I did not have one at the time of offense;  
*(Some offenses are eligible for deferral for CDL holders – An appearance in court is required)*
4. The offense committed was not in a construction zone with worker's present;
5. I am not currently on Deferred Disposition with the City of Lake Worth;
6. I must pay the fine, court costs and a \$30.00 special expense fee in the total amount of \$\_\_\_\_\_ (contact court or see fine list on website);
7. I have included payment in full or I am requesting time to pay in full by marking one:  
 pay in full       30 days to pay
8. If I was under the age of 25 on the date of my citation and I was charged with a moving violation, I will be required to complete a Driver's Safety Course and submit proof of such to the Court within 60 days of the granting of this motion;

I understand that, if approved, the Court will defer further proceedings without entering an adjudication of guilt and place me on a probation period not to exceed 180 days during which time I must not receive any violation in the City of Lake Worth and must comply with all probation requirements. If I successfully complete all the conditions of probation set out in the Deferral Order then case will be dismissed and will not appear on my driving record as a conviction. (A copy of the Deferral Order will be sent to the address provided below.)

I understand if I violate any term or condition of my deferral I will be required to appear at a hearing with the Judge. Notice of the hearing will be sent to the last address on file. Failure to appear at this hearing will result in a conviction and will be reported as required by law.
