

## NOTICE VIRTUAL PUBLIC MEETING Farm-to-Market 1220 (Boat Club Road) From Azle Avenue to W. Bailey Boswell Road CSJ: 2079-01-042 Tarrant County, Texas

The Texas Department of Transportation (TxDOT) is proposing to improve Farm-to-Market (FM) 1220 (Boat Club Road) from Azle Avenue to W. Bailey Bowell Road in Tarrant County, Texas. This notice advises the public that TxDOT will be conducting an online virtual public meeting on the proposed project. The virtual meeting will be held on **May 28, 2020 at 6 p.m.** To log onto the virtual public meeting, go to the following web address at the date and time indicated above: <u>www.txdot.gov</u> Search: FM 1220 Boat Club Road. Project staff will give a presentation regarding the project. The presentation will include both audio and visual components. If you do not have internet access, you may call Ngozi Lopez by phone at (817) 399-4300 to ask questions about the project and access project materials at any time during the project development process. Formal comments may be provided by mail or email as explained below.

The existing curb and gutter roadway within the project limits consists of four 12- foot travel lanes with a 14-foot two way continuous left-turn lane. The proposed project would enhance safety and improve access along FM 1220/Boat Club Road by constructing a raised center median in place of the two-way continuous left-turn lane for a distance of approximately 4.6 miles. The proposed typical section would consist of two 11-foot travel lanes in each direction with either a 15- to 16-foot-wide raised curb median or a 4- to 5-foot-wide raised curb median with an 11-foot-wide turn lane. The raised curb median with an 11-foot wide turn lane would be constructed where median openings are proposed at cross streets and major developments. There are no anticipated right-of-way impacts.
