A tax rate of \$0.438928 per \$100 valuation has been proposed by the governing body of Lake Worth.

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for Lake Worth from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that Lake Worth may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Lake Worth is not proposing to increase property taxes for the 2022 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 20, 2022 AT 6:30 PM AT 3805 ADAM GRUBB, LAKE WORTH, TEXAS 76135.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Lake Worth is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of Lake Worth at their offices or by attending the public meeting mentioned above.
