

Park Rules and Regulations

General Rules and Regulations

- Park Hours are as specified by city ordinance for each individual park.
- Glass containers are prohibited.
- Alcohol is prohibited in the park unless authorized by the City Council (Lake Worth Code of Ordinances Section 1.604).
- Firearms, Air guns, fireworks, paint ball, and bow and arrows are prohibited.
- Concealed Handgun License holders may possess a firearm pursuant to Texas Penal Code Chapter 46 and Texas Government Code Chapter 411.
- Only City provided park grills may be used in designated park and pavilion areas. Personal grills and/or smokers are prohibited unless written approval by Park Superintendent has been obtained.
- All pets on park property must be on a leash at all times, except when in designated no leash areas. No pets are allowed on any of the ball fields at any time.
- Swimming, wading, boating, and/or flotation devices are prohibited. Model radio controlled boats are welcome.
- Fishing is allowed during park operational hours. Trotlines and nets are prohibited.
- Do not throw rocks at others and/or waterfowl.
- Park in designated parking areas only, no parking on grass areas. Motorized vehicles are prohibited on hiking trails or other park lands.
- No motorized vehicles and/or power equipment on the ball fields at any time.
- Use trail courtesy. Stay to the right of the trail; pass on the left. Cyclist and skaters yield to pedestrians.
- Skating, skate boarding, roller blading, bicycling, or scooters permitted on hiking trail areas only. These activities are prohibited in all pavilion areas.
- No horseback riding allowed in the park. Livestock are prohibited in the park without written permission.
- No soliciting or vending allowed in the park at any time.

Dog Park Rules and Regulations

Visitors to the Keenum-Shelton Park are subject to the same rules as above with the addition of the following:

- Dogs must be licensed and have current rabies vaccination on their tags.
- Dogs belonging to Lake Worth residents must display a city license issued by Animal Services.
- Dogs are to remain on a leash while entering and exiting designated areas.

- Dogs must be kept on a leash until inside the double-gated entry.
- Owners are to stay within the park and within view of their dogs.
- Dogs shall be under the voice control of their owners at all times.
- Any dog exhibiting aggressive behavior must be removed immediately.
- Owners must carry a visible leash at all times for their pet.
- Owners are responsible for removal and disposal of feces of their dogs.
- All children must be under strict supervision and an adult must accompany those under the age of 12.
- No puppies under 4 months of age.
- Dogs in heat are not allowed.
- Park users and dog owners assume all risks related to dog park use.
- The small dog area is for animals less than 40 lbs. only. Small dogs may play in the large dog area at their own risk, but this is not recommended.
- Owners shall repair any damage done by their dog (i.e., holes dug by the dog).
- No food or drink allowed in the dog park.
- Owners waive liability of the City for any injury or damage caused to or by pets during any time while using the park.
