<b>The following guidelines apply for this permit:</b> 1) Irrigation system must be installed in accordance with TCEQ requirements and the City of Lake Worth Ordinance(s). 2) Irrigation system must be tested by a licensed Backflow Prevention Assembly Tester who is registered with Lake Worth. 3) Backflow Test report must be turned in to City Hall upon completion and prior to the permit being closed. 4) Permit and inspection fees are \$60.00-RESIDENTIAL/ \$120.00 COMMERCIAL (reinspection fees may be assessed as necessary)

The authority having jurisdiction shall be permitted to grant an extension of the permit time period for an additional 180 days upon written documentation by the permittee of a satisfactory reason for failure to start or complete the work or activity authorized by the permit. **Only one extension will be allowed. I understand that all permits require a final inspection.**
